

## **Scooter and BYU Ticket Giveaway Contest Official Rules**

**Binding Agreement.** By participating in this agreement, you acknowledge that you have read and agree to be bound by these Official Contest Rules.

**Definitions:** As used in these Contest Rules, the terms “you” and “your” mean those who enter the Contest by completing the steps described in the herein and in any other Contest Materials. “Contest Materials” means the materials or media that DFCU uses to announce and market the Contest.

**Prizes.** DFCU will award each of the following prizes: one (1) New Lance Cali Classic 125cc Scooter (“Scooter”); two (2) tickets to each of the following BYU football games (“Tickets”): (1) BYU v South Florida (October 12, 2019); (2) BYU v. Utah State (November 2, 2019); BYU v. San Diego State (November 30, 2019).

**Contest Run Time.** The contest will be held from September 12, 2019 to September 30, 2019.

**Eligibility.** Any U.S. resident over the age of eighteen (18) is eligible to win. Current DFCU employees are not eligible.

**Entry.** To enter simply complete one of the following: (1) visit DFCU’s Provo Branch and submit your “why statement” (one entry ticket); (2) open a new DFCU Account (three entry tickets); (3) open a new DFCU loan (three entry tickets). One entry per method per person.

**Entry by Mail.** Entries may also be made without purchase by mailing a 3”x5” card with your name, home address, day and evening phone numbers, and email address to: Deseret First Credit Union, Marketing Department, P.O. Box 45046, Salt Lake City, Utah 84145-0046. Limit one entry by mail per person.

**Selection and Announcement of Winner.** The winner will be randomly selected from among all eligible entries. The winner will be notified within 48 hours of the close of the contest. DFCU reserves the right to announce and notify the winner up to one week after the close of the contest. The winner will be notified by DFCU through any means available to DFCU and in DFCU’s sole discretion.

**Redeeming the Prize.** The winner of the Scooter must redeem the Scooter by personal pickup at Scooter Lounge located at 302 S 500 W, Provo, UT 84601, within seven (7) days of notification. The winners of the Tickets must redeem the Tickets by personal pickup at DFCU’s Provo Branch within seven (7) days of notification. The winners should bring a valid form of picture ID. Should a winner forfeit his/her prize or otherwise be found ineligible another winner may be selected in DFCU’s sole discretion.

**Title and Insurance.** The winner of the Scooter is responsible for paying all sales taxes, registration fees, and insurance costs associated with the Scooter.

**Odds.** The odds of winning are dependent on the number of entries received.
