

DFCU Summer Bash Top Golf Giveaway Rules

Binding Agreement: By participating in the Summer Bash 2022 (“Contest”), you acknowledge that you have read and agree to be bound by the (“Contest Rules”).

Definitions: As used in these Contest Rules, the terms “you” and “your” mean those who enter the Contest by completing the steps described in the herein and in any other Contest Materials. “Contest Materials” means the materials or media that DFCU uses to announce and market the Contest.

Contest Run Time: Contest will be held from April 20, 2022 through June 14, 2022.

Prizes: DFCU will award up to (5) spots to an individual loanee. They will then have the option to bring (4) family members or friends.

Eligibility: Any lawful U.S. resident over the age of eighteen (18). DFCU employees, their spouses and children under 18 are ineligible for the Contest. Limit one (1) prize per person.

Entry: Enter to win by being a Deseret First Credit Union member and completing the entry form.

Entry by Mail: Entries may also be made without purchase by mailing a 3”x5” card with your name, home address, day and evening phone numbers, and email address to: Deseret First Credit Union, Marketing Department, P.O. Box 45046, Salt Lake City, Utah 84145-0046.

Selection and Announcement of Winners: Winners will be randomly selected at the end of the Contest Run Time. Winners, generally, will be announced and notified within 12 hours of the close of the contest, but DFCU reserves the right to announce and notify the winner up to one week after the close of the contest. Winners will be notified through any means available to DFCU and within DFCU’s sole discretion (e.g. telephone, email, Facebook message, etc.).

Redeeming the Prizes: Within 48 hours after DFCU has notified or attempted to notify a winner, the winner must contact DFCU to work out the delivery/pickup of his/her prize within a reasonable timeframe. If delivery/pickup does not occur within a reasonable timeframe or the winner does not contact DFCU then DFCU, in its sole discretion, may select another winner and the original winner will forfeit his/her prize. Each winner will be required to provide valid identification to redeem his/her prize.

Odds: The odds of winning are dependent on the number of entries received.
