**METHOD OF PROVIDING COMMUNICATIONS TO YOU IN ELECTRONIC FORM.** All Communications that we provide to you in electronic form will be made available either (i) via email; or (ii) online at DFCU's website (www.dfcu.com).

All account statements will be provided to you electronically through DFCU's Online Banking.

**OBTAINING PAPER COPIES.** DFCU will provide all required Communications to you in electronic format unless you request a paper copy, or we deem it appropriate to send you a paper copy. You may obtain a paper copy of an electronic Communication by printing it yourself or by requesting that we mail you a paper copy.

**WITHDRAWING CONSENT.** You have the right to withdraw your consent at any time. If you withdraw your consent, any Communication required to be provided to you after the effective date of the withdrawal will be provided to you in paper form.
